FURTHERMORE, THAT I DO NOT NOW, AND I NEVER WILL HOLD MEMBERSHIP IN OR ALLEGIANCE TO ANY BODY CLAIMING TO BE MASONIC THAT HAS BEEN DECLARED CLANDESTINE BY A COMMANDERY OR PRECEPTORY OF KNIGHTS TEMPLAR OR CONSISTORY OF THE ANCIENT AND ACCEPTED SCOTTISH RITE OF FREE MASONRY OF THE OBEDIENCE OF EITHER THE SUPREME COUNCILS OF THE NORTHERN OR SOUTHERN MASONIC JURISDICTION OF SUCH RITE IN THE UNITED STATES, OR THOSE SUPREME COUNCILS WHICH ARE IN AMITY WITH AND RECOGNIZED BY THEM: THAT I HAVE RESIDED WITHIN THE JURISDICTION OF YOUR TEMPLE, OR IN UNOCCUPIED TERRITORY, NOT LESS THAN SIX MONTHS, AS REQUIRED BY THE CONSTITUTION OF THE IMPERIAL COUNCIL, AND THAT I AM NOT UNDER SUSPENSION OR EXPULSION IN EITHER OF THE BODIES PREREQUISITE TO THIS ORDER, AND RESPECTFULLY PRAY THAT I MAY BE MADE A NOBLE OF THE MYSTIC SHRINE, AND BECOME A MEMBER OF YOUR TEMPLE.

I FURTHERMORE REPRESENT THAT I HAVE NEVER PREVIOUSLY APPLIED FOR SAID ORDER, NOR HAVE I, TO MY KNOWLEDGE BEEN REJECTED BY ANY OTHER TEMPLE. IF I BE FOUND WORTHY, AND MY REQUEST GRANTED, I PROMISE TO CONFORM TO ALL THE CEREMONIES, ENGAGEMENTS, CONSTITUTIONS, REGULATIONS AND EDICTS OF THE IMPERIAL COUNCIL TOGETHER WITH THOSE OF YOUR TEMPLE.
